

ORDINANCE NO. 2025-01

**AN ORDINANCE AUTHORIZING A ONE TIME \$10.00 CREDIT
TO THE UTILITY BILL OF RESIDENTS WHO PARTICIPATED
IN THE LEAD AND COPPER SAMPLING REQUIRED BY THE
EPA.**

WHEREAS, the Village of Bellaire was required to send in water samples from 45 residents as part of EPA requirements; and

WHEREAS, in order to increase participation, it was decided to offer a one time \$10.00 credit on the participants utility bill; and

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BELLAIRE, COUNTY OF BELMONT, STATE OF OHIO:


SECTION 1: That the list of customers attached as Exhibit A are granted a one-time utility bill credit of \$10.00 to be applied as soon as practical in exchange for their participation in the Lead and Cooper sampling required by the EPA.


SECTION 2: That all other Ordinances or Resolutions, or portions thereof, which are in conflict with this Ordinance are hereby repealed.

SECTION 4: That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.

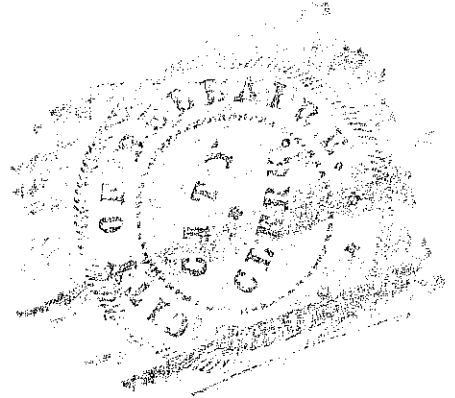
