

ORDINANCE NO. 2025- 25-04

**AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO
EXECUTE A CONTRACT WITH THE REGIONAL COUNCIL OF
GOVERNMENTS FOR THE PURPOSE OF ADMINISTRATION AND
COLLECTION OF MUNICIPAL INCOME TAX IN THE VILLAGE OF
BELLAIRE, OHIO.**

WHEREAS, a Regional Council of Governments was created pursuant to Chapter 167 of the Ohio Revised Code to foster cooperation between municipalities, and

WHEREAS, the creation of the Regional Council of Governments was primarily to establish a central collection facility (Regional Income Tax Agency) for the purpose of administering the Income Tax Laws of the various participating members communities.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BELLAIRE, COUNTY OF BELMONT, STATE OF OHIO:

SECTION 1: That the Mayor be and is hereby authorized and directed to execute, on behalf of the Village of Bellaire, a contract with the Regional Council of Governments for the administration and collection of the Village of Bellaire's Income Tax through the Regional Income Tax Agency.

SECTION 2: The Village of Bellaire Fiscal Officer is hereby appointed as the Village's representative to the Regional Council of Governments and the Mayor of the Village is designated as alternate to the Council of Governments.

SECTION 3: That all other Ordinances or Resolutions, or portions thereof, which are in conflict with this Ordinance are hereby repealed.

SECTION 4: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including section 121.22 of the Ohio Revised Code.

SECTION 5: That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.

Adopted at a regular meeting of the Council of the Village of Bellaire held this 26th day of March, 2025 by the 3-2 yeas votes of its eligible members.
